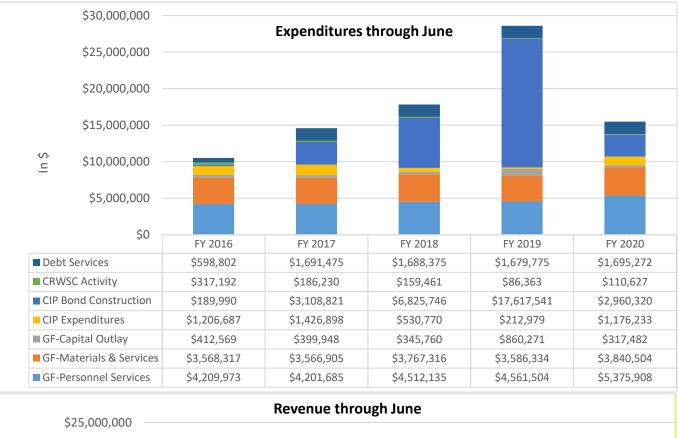

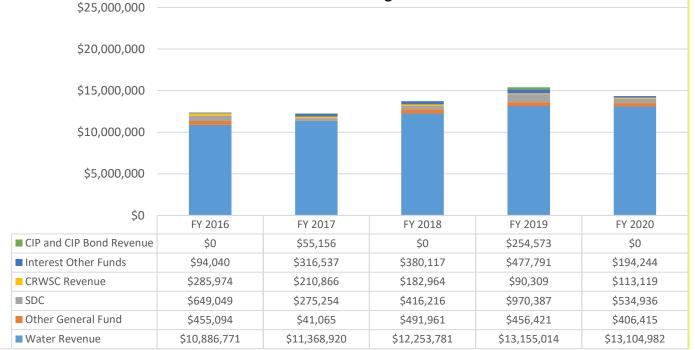

# **Financial Reports**

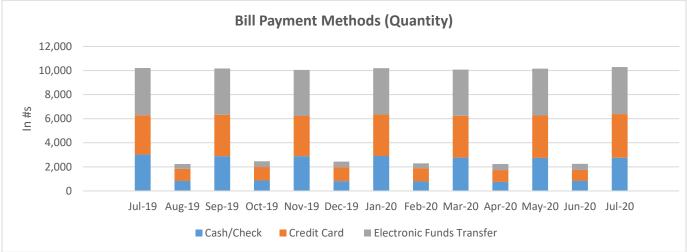


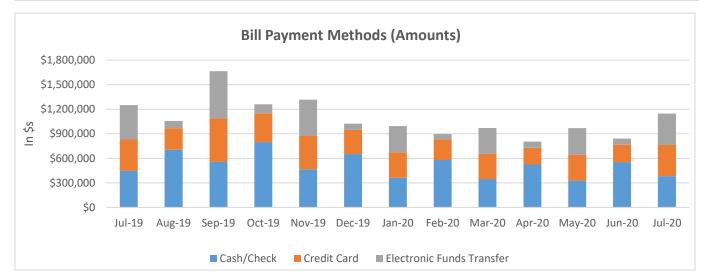


**Revenue:** Demand compared with FY 19 is down by 5.29% through the June billing. Water sales revenue dollars are consistent with FY 19. We continue to see some impact from the Stay Home/Save Lives order as many businesses have been closed, yet apartment complexes had higher than normal consumption. A portion of the reduced consumption could have been the result of the decrease in average temperatures this past summer that continued into the fall that we have been seeing throughout the fiscal year. Interest earnings for June 2020 haven't been recorded to revenue as of today, so revenue will go up by \$13,000 allocated across funds. **Expenses:** Personnel services expense dollars are significantly higher than prior years due to the payment of the budgeted PERS Transitional Liability. Exclusive of the PERS payment, Personnel Services are 43.44% of the biennial budget. Materials & Services are at 43.39% of the biennial budget and 86.75% of the FY 20 estimate. Additional expenditures for FY 20 are continuing to be recorded through this week.

# Sampling Reports

### Regulatory

All 84 samples collected and analyzed for the July monitoring period showed no presence of coliform/*E. coli* bacteria.

Quarterly Disinfection By-Product sampling was conducted at 4 locations each in the North and South Service Areas.

#### **Cyanotoxin Testing**

Microcystin and Cylindrospermopsin sampling of our raw water began in May and occurs every two weeks for compliance.

We have analyzed one sample each week since May 19<sup>th</sup> from a bloom in Timothy Lake for PGE for Total Microcystin, Cylindrospermopsin, Anatoxin-a and Saxitoxin. At the same time, we ran additional raw water samples from our intakes.

No cyanotoxins were detected in our raw water.

#### **Non-Regulatory**

General water quality parameters (pH, temperature, chlorine, TDS, harness, alkalinity) were collected for the distribution system at 16 locations in the North and South systems.

Monthly watershed sampling was conducted at 4 long-term sampling locations for total organic carbon, nutrients (nitrate/nitrite, total phosphorus, orthophosphate, etc.) coliform density, pH, dissolved oxygen, TDS, and temperature.

Weekly algae monitoring is occurring at 3 locations in the North Fork Reservoir and CRW's intakes. This work includes species monitoring with the FlowCAM and nutrient analysis.

Raw water at our intakes was also tested for giardia and cryptosporidium, as we do each month.

## **Sampling for Other Agencies**

All 50 samples collected and analyzed during this period for Sunrise Water Authority showed no presence of coliform/*E.coli* bacteria.
