





Revenue: Demand was decreased by 5.45% through February 2020 from the prior year. This could have been the result of the decrease in average temperatures this past summer that continued into the fall and we are seeing the consumption variance growing smaller through the winter months.

Expenses - Personnel Services expense is significantly higher than prior years due to the payment of budgeted PERS Transitional Liability. Exclusive of the PERS Transitional Liability payment, personnel services are 27.74% of the biennial budget. Materials & Services are at 29.14% of the biennial budget in alignment with 33.33% of the two-year budget cycle through February.

Residential Customers are billed on the even months, Commercial Customers are billed on the odd months.






Credit Card — Received via CRW Initiated Automatic Payment, Walk-ins/Phone Calls, and Website


Electronic Funds Transfer — Received via Bank to Bank Transfer, Automatic Checking Withdrawal (RapidPay)





Regulatory

All 84 samples collected and analyzed for the February monitoring period showed no presence of coliform/*E. coli* bacteria.

Non-Regulatory

General water quality parameters (pH, temperature, chlorine, TDS) were collected for the distribution system at 17 locations in the North and South systems and at 10 locations in the Sunrise Water Authority system.

Monthly watershed sampling was conducted at 4 long-term sampling locations for total organic carbon, nutrients (nitrate/nitrite, total phosphorus, orthophosphate, etc), and volatile organic carbon compounds (VOCs, 21 regulated for drinking water, 36 unregulated).

Sampling for Other Agencies

All 50 samples collected and analyzed during this period for Sunrise Water Authority showed no presence of coliform/*E.coli* bacteria.

Quarterly Disinfection By-Product sampling was conducted at 4 locations for Sunrise Water Authority.

Winter Conditions Report

Current Oregon statewide snow water equivalent is 94 percent of normal, down from 97 percent two weeks ago.

Current Oregon statewide precipitation at NRCS SNOTEL sites is 83 percent of average, remaining below average for the water year.

Over the next 8 to 14 days, the NOAA Climate Prediction Center is forecasting below normal temperature probability across all but the southeast third of the state where equal chances are forecast. The most recent three-month outlook indicates an increased probability of above normal temperatures across the state. The precipitation outlook for the same period is for below normal probability across most of western Oregon with equal chances of above or below normal probability for the rest of the state
